- The 2019 Minnesota Legislature enacted a law that requires clinics to report information about the 25 most frequent services they provide that cost more than \$25. The law requires clinics to post their starting charges, expected payment rate from Medicare, Medicaid, and average amount paid by Commercial Insurance companies.
- The amounts posted do not reflect the amount individual patients or their health insurance plan will owe for the services listed. For specific information about the amount you will owe for the services you receive, please contact your insurance company.
- Charges represent the standard amount Sleepy Eye Medical Center bills for any service. Most often, charges are not the amount the clinic actually gets paid for the service. For most patients, clinics are paid at a level well below these charges.
- **Patients covered by Commercial Health Insurance companies or a Medicare Advantage plan:** Your health insurance company has likely negotiated a discount or contracted rate for service. Your health insurance company's negotiated price might be higher or lower than the average commercial payment amount listed above. To learn more about your health insurance company's negotiated price or how much you will owe under the terms of your specific health insurance policy, please contact your health insurance company by calling the number listed your insurance card.
- Rural Health Clinics are paid on an all-inclusive rate from Medicare and Medicare Advantage for medically-necessary evaluation and management visits. The all-inclusive rates are subject to maximum payment per visit is and established by congress and updated annually based on the percentage change in the Medicare Economic Index and subject to annual reconciliation.
- Medicaid reimbursement to Rural Health Clinics based upon a rate determined by DHS.
- When patients want to shop for medical services, they should contact their own insurance company to get information about which costs will be covered by the insurance company and which will be the patient's responsibility.
